## **Purposes of processing**

## **Legal basis for the processing**

The processing of (collection, storage, transfer to third parties and publication) of selected text or photo files in (print) publications of the Hochschule Darmstadt – University of Applied Sciences and on its homepage or similar is necessary for public relations work and information about studies and teaching is based on the explicit consent of the person(s) concerned in accordance with Art. 6 para. 1

a) GDPR.

### **Recipient of the personal data**

The photos may be passed on to service providers for publication in accordance with Art. 28 GDPR in connection with the production of print products. These include agencies and printshops involved in the production. For the purpose of publication on the Internet, they may be placed on the homepage of Hochschule Darmstadt – University of Applied Sciences and used for the social media channels of Hochschule Darmstadt – University of Applied Sciences in accordance with the respective consent of the subject (Art. 6 para 1 a) GDPR.

### **Duration of storage of personal data**

Photographs taken for the purposes of the Hochschule Darmstadt – University of Applied Sciences' public relations work will be stored for an indefinite period of time for a specific purpose, subject to revocation of the consent of the person(s) concerned.

### **Right of withdrawal of consent**

The consent to process the photos can be revoked at any time for the future. The legality of the data processing carried out on the basis of the consent until the revocation is not affected by this.

### **Rights of data subjects**

You can exercise the following rights at any time by contacting our (Hochschule Darmstadt) data protection officer:

- Information about your data stored with us and their processing,
- Correction of incorrect personal data,
- Deletion of the personal data concerning you, provided that the conditions for deletion are met,
- Restriction of data processing, provided that we are not yet allowed to delete your data due to legal obligations,
- Revocation of your consent,
- Objection to the processing of your data by us.

### **Right of appeal of the person concerned**

Those affected have the right to complain to the responsible technical supervisory authority in the event of data protection problems.
